Dear Drs. Yucius and Sones,

It was our pleasure to examine Diddy Flowers today.

Presenting Concern:

Squamous cell carcinoma right mandible.

History:

Diddy presented to the RDVM on 2/11/19 and an oral growth that was noticed a few weeks prior (initially thought to be an abscessed tooth) was removed and meloxicam and tramadol were dispensed. Tissue was submitted for histopathology and came back as a

squamous cell carcinoma. On 2/25 the RDVM dispensed trazodone, carprofen,

acepromazine and amoxi/Clav on 2/25. Diddy presented to Dr. Sones on 3/8/19, a 1.5cm firm, fixed, necrotic mass was noted on the right lateral mandible, surgical excision was recommended and clindamycin was dispensed. Ms. Flowers reported that it seems like Diddy has some difficulty picking up food on R side of mouth and there is a foul odor. Aside from having a bilateral anal sacculectomy (chronic expressing and inflammation),

no other health issues were noted. E/D well.

Medications:

Sentinel Spectrum, Carprofen 37.5mgs PO SID, Trazodone 50mgs PO before traveling/vet

visits, Acepromazine 10mgs PO before traveling/vet visits.

The right mandibular LN is enlarged on palpation.

Hydration:

Normal.

Oral Exam:

There is a 2cm (Cr/Ca) x 1.8cm (DV) dermal mass that extends from the level of the 3rd premolar caudally. A limited oral examination reveals an ulcerated, raised lesion/mass on

the lateral surface of the mandible the inner lip, extending from the 2nd premolar caudally, but due to Diddy's poor cooperation, I was unable to assess how far the mass extended caudally, or if the mass involved the fauces or the lingual mucosal surface.

Cardiovascular:

No obvious murmur noted.

Respiratory:

Normal bronchovesicular sounds.

**Abdominal Palpation:** 

Soft, non-painful. No palpable organomegaly.

Rectal Examination:

Did not examine.

Urogenital:

Appears normal.

Diagnostics Performed.

3 view chest and a lateral cervical radiograph were taken and submitted for a radiology

consult. An ECG was transmitted to IVS and was normal.

Assessment:

Oral squamous cell carcinoma, possible enlargement of the retropharyngeal LN on

radiographs.

Recommendations:

Pending the radiology report, a CT may be recommended to obtain more information prior to surgery. We may also wish to sedate Diddy prior to surgery to obtain better knowledge of the extent of the mass. Surgical excision of this mass would involve a hemimandibulectomy, with reconstruction of the defect with a rotation or advancement flap. Dogs typically do well with this procedure, with wound dehiscence being the most

common complication.

Pending the radiology report.

Diddy presented to the RDVM on 2/11/19 for a dental and removal of an oral growth that was noticed a few weeks prior (initially thought to be an abscessed tooth). The mass was biopsied and histopathology confirmed a squamous cell carcinoma. There is a 2 x 1.8 cm ulcerated mass on R lower lip, also involving the buccal mucosa and lateral surface of the mandible, extends from 3rd premolar caudally. Mandibular LN prominent, suspect enlarged retropharyngeal LN on radiographs. Met check performed.

**Findings** 

Available are left lateral, right lateral and VD projections of the thorax, as well as to lateral projections of the neck.

The cardiovascular structures are normal, with a vertebral heart score of 10.4. The pulmonary parenchyma is normal with no evidence of soft tissue opaque nodules.

There is mild thickening of the soft tissues seen between the larynx and C2, in the region of the medial retropharyngeal lymph nodes, however the fascial planes remain well-defined and smoothly margined.

#### Conclusions

1. Unremarkable thorax with no evidence of pulmonary metastases.

2. Possible medial retropharyngeal lymphadenopathy. Ultrasound-guided fine-needle aspirates could be performed for a more definitive diagnosis.

## CLINICAL FINDINGS & PERTINENT HISTORY:

Oral SCC on right side. Rads - retropharyngeal lymphadenopathy.

## SONOGRAPHIC FINDINGS:

Cervical ultrasound:

Retropharyngeal lymph nodes are bilaterally enlarged. The right measures 3.4 x 0.97 cm and is hypoechoic to mixed echoic with heterogenous parenchyma and multifocal areas of mineralization. The left measures 2.7 x 0.61 cm and also has a hypoechoic to mixed echoic, heterogenous appearance.

FNA performed of the right retropharyngeal lymph node. Cytology pending.

Post FNA revealed no evidence of hemorrhage.

#### HISTOPATH REPORT:

DESCRIPTION/MICROSCOPIC FINDINGS/COMMENTS:
DESCRIPTION In the 4 samples from the right fauces submitted, there is epithelial acanthosis. Basement membrane supporting the hyperplastic epithelium are intact and there is no scirrhous response. There is occasional dyskeratosis. There is submucosal lymphoplasmacytic inflammation. There is fibroplasia neovascularization.

MICROSCOPIC FINDINGS:

CHEILITIS, LYMPHOPLASMACYTIC, EROSIVE, PROLIFERATIVE, SUBMUCOSAL FIBROPLASIA NEOVASCULARIZATION AND SEGMENTAL DYSPLASIA

COMMENT There is no evidence of squamous cell carcinoma or other malignancy in the 4 samples provided. Changes are consistent with chronic irritation and reparative proliferation.
